RESOLUTION NO. 102 S-2018

A RESOLUTION RATIFYING THE IMPLEMENTING RULES AND REGULATIONS (IRR) OF MUNICIPAL ORDINANCE NO. 2018-004, “AN ORDINANCE ESTABLISHING SCHOLARSHIP FUND FOR POOR BUT DESERVING STUDENTS RESIDING WITHIN THE MUNICIPALITY OF GUBAT”.

WHEREAS, Section 6 of Municipal Ordinance No. 2018-004 provides that the Scholarship Committee shall formulate an Implementing Rules and Regulations (IRR) to provide proper guidelines in the implementation of this Ordinance. The IRR shall include among others the criteria for application, selection and approval of applicants consistent with the policy to establish scholarship program to poor but deserving students acquiring accessible, quality, adequate education in the tertiary level, subject to the ratification by the Sangguniang Bayan and final approval of the Municipal Mayor;

WHEREAS, said Implementing Rules and Regulations (IRR) is now submitted by the Scholarship Committee before this Sanggunian Bayan for ratification;

WHEREAS, after careful review by the Sangguniang Bayan, said Implementing Rules and Regulations (IRR) is found to be in compliance with the legislative intent of the Ordinance in providing Scholarship Program to poor but deserving students residing within the Municipality of Gubat, and enrolled in the tertiary level of Bicol University, Gubat Campus and Sorsogon State College Campuses;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, to ratify the Implementing Rules and Regulations (IRR) of the Municipal Ordinance No. 2018-004, “An Ordinance Establishing A Scholarship Fund for Poor but Deserving Students Residing within the Municipality of Gubat”;
