A RESOLUTION DECLARING THE DROPPING OF MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOP) IN THE MUNICIPALITY OF GUBAT IN THE NAME OF ANALIZA C. BONTO WITH CASE NUMBER 05-09-1104, EMMANUEL P.
