A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO EXIT MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL OFFICE NO. V AND ASSOCIATION OF BARANGAY CAPTAINS (ABC) RELATIVE TO THE CONCLUDED IMPLEMENTATION OF KALAHY-CIDSS-NCDDP IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the implementation of Kapit-Bisig Laban sa Kahirapan Comprehensive and Integrated Delivery of Social Services-National Community Drive Development Program (KALAHY-CIDSS-NCDDP) has successfully ended in the Municipality of Gubat, Sorsogon;

WHEREAS, the Barangays signifies their intention to adopt key development processes introduced by the KALAHI-CIDSS program in its regular governance processes and system in order to further enhance gains through the implementation of the project in the barangay;

WHEREAS, this Municipality expresses its interest and commitment to adopt the Community Driven Development (CDD) Principles, Sub-Project Cycle and Approaches to improve living conditions of its poor constituent, and further acknowledges its primary role in ensuring sustainability of implemented sub-projects and other gains;

WHEREAS, the Municipality of Gubat through an Exit Memorandum of Agreement agrees to continue its partnership with the Association of Barangay Captains (ABC) and Department of Social Welfare and Development (DSWD) in ensuring sustainability of implemented sub-projects and gains;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G.
