A RESOLUTION APPROVING THE REPROGRAMMING OF FUNDS IN THE AMOUNT OF EIGHT MILLION THREE HUNDRED FORTY-EIGHT THOUSAND EIGHT HUNDRED THIRTY-FIVE PESOS AND THIRTY-EIGHT CENTAVOS (₱8,348,835.38) PESOS FROM THE PROGRAMS/PROJECTS AND ACTIVITIES UNDER THE LOCAL 20% DEVELOPMENT FUND FOR FISCAL YEAR 2017 OF THE MUNICIPALITY OF GUBAT, SORSOGON.
