WHEREAS, the Department of Health hereby donates to the Local Government Unit of Gubat the medical and laboratory equipment equivalent to an amount of Two Million Three Hundred Nineteen Thousand Nine Hundred Sixty One and 78/100 (P2,319,961.78);

WHEREAS, this local government unit hereby acknowledges receipt and/or acceptance of the medical and laboratory equipment subject of the donation, and fully assumed its duties and responsibilities attached to the donation;

WHEREAS, said donation will provide this LGU's health facilities with basic medical equipment to improve delivery of primary health care services;
