RESOLUTION NO. 135 S – 2018

A RESOLUTION TO INCLUDE HON. NORVEN E. ARIOLA, SK MUNICIPAL FEDERATION PRESIDENT, AS MEMBER OF THE SANGGUNIANG BAYAN COMMITTEE ON HEALTH AND SANITATION, COMMITTEE ON EDUCATION, AND COMMITTEE ON ENVIRONMENT AND NATURAL RESOURCES IN COMPLIANCE WITH REPUBLIC ACT NO. 10742 OTHERWISE CALLED “THE SANGUNIANG KABATAAN REFORM ACT OF 2015”.
