RESOLUTION NO. 143 S-2018

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTO) IN THE MUNICIPALITY OF GUBAT OF MILAGROS TABIRAO WITH CASE NUMBER 05-09-2556 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF SEPTEMBER 2018.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the above-named applicant applied before this office for the suspension of their MTO for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable Cesar D. Esperida, Jr. and duly seconded by Honorable Kenneth D. Escandor, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTO) in the Municipality of Gubat of Milagros Tabirao with case number 05-09-2556 for a period of one (1) year starting this month of September 2018;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting this month of September 2018;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicant and others concerned for their information and guidance.
