RESOLUTION NO. 144 S-2018

A RESOLUTION ADOPTING THE LOCAL YOUTH DEVELOPMENT PLAN (LYDP) FOR FY 2018 – 2020 OF THE SANGGUNIANG KABATAAN OF THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON.

WHEREAS, Section 23 of Republic Act 10742 provides that the Local Youth Development Council (LYDC) shall assist the planning and execution of projects and programs of the Sangguniang Kabataan and the pederasyon in all levels, in formulating the Local Youth Development Plans in preparation for the Comprehensive Barangay Youth Development Plan (CBYDP) and the Annual Barangay Youth Investment Program (ABYIP);

WHEREAS, Section 8 (h) of the same law also provides that the LYDC and the Sangguniang Kabataan shall be partners in planning and executing projects and programs of specific advocacies like good governance, climate change adaptation, disaster risk reduction and resiliency, youth employment and livelihood, health and anti-drug abuse, gender sensitivity and sports development;

NOW, THEREFORE, on motion of Hon. Norven E. Ariola and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to adopt the Local Youth Development Plan (LYDP) for FY 2018 - 2020 of the Sangguniang Kabataan of the Municipality of Gubat, Province of Sorsogon;
