ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO TRIPARTITE MEMORANDUM OF UNDERSTANDING WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGIONAL OFFICE NO. V, AND WITH THE ABS-CBN LINGKOD KAPAMILYA FOUNDATION, INC. REGARDING DEVELOPMENT OF PANGANIBAN MANGROVE ECO-TOURISM PROJECT.
