WHEREAS, the Local Government Unit of Gubat has already completed the project proposal for the land development of Gubat Resettlement Project at Brgy. San Ignacio. Gubat, Sorsogon in the amount of Eleven Million Nine Hundred Ninety-Nine Thousand Eight Hundred Ninety-One Pesos and Ninety-Eight Centavos (P 11,999,891.98);

WHEREAS, this proposed Land Development Project primarily covers the provisions on road worthiness, drainage and other miscellaneous works necessary for easy access and protection of the resettlement area;

WHEREAS, there is an immediate need for the implementation of this land development project to make the resettlement area fully operational and accessible in preparation for the impending relocation of informal settlers from the Gubat National High School premises affected by the construction of senior high school building and of those families situated at hazardous areas from coastal and landslide pruned areas of the municipality;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, endorsing to the National Housing Authority (NHA) the proposed project for land development of San Ignacio Resettlement Project, San Ignacio, Gubat, Sorsogon;
