RESOLUTION NO. 17 S-2018

A RESOLUTION ENDORSING THE LIGA RESOLUTION NO. 01 SERIES OF 2018, EARNESTLY REQUESTING FROM HON. CONG. DEOGRACIAS B. RAMOS, JR. REPRESENTATIVE OF 2ND DISTRICT OF SORSOGON FOR FINANCIAL ASSISTANCE TO PROVIDE MEDICAL SUPPLIES AND MEDICINES NEEDED FOR THE “OPERATION TULI”, A JOINT PROJECT OF THE LIGA NG MGA BARANGAY AND SANGGUNIANG BAYAN OF GUBAT, SORSOGON.

WHEREAS, R.A. 7160, otherwise known as the Local Government Code of 1991, delegated specific functions and responsibilities to local government units (LGU’s) particularly on the effective and efficient delivery of basic services and facilities at the local level;

WHEREAS, there is an urgent need to provide fund assistance to LGUs in order to alleviate their financial burdens in carrying out the devolved functions and responsibilities, as specified by the Code;

WHEREAS, the Sangguniang Bayan in coordination with the Liga ng mga Barangay will spearhead a project known as "Operation Tuli" this summer break of 2018;

WHEREAS, the proposed 2-day activity will be clustered into 2 batches composed of 21 barangays from North District on the first day and 21 barangays from South District on the second day;

WHEREAS, that this program is originally sponsored by the Department of Health but the Sangguniang Bayan and Liga ng mga Barangay President both of this Municipality would like to extend this project to provide basic healthcare services for the boys and offers free and safer circumcision with the assistance of the medical personnel;

WHEREAS, the LGU of Gubat, Sorsogon through the Municipal Health Office annually conduct and support Barangay's "Operation Tuli" activities to wit;

WHEREAS, in order for this undertaking to be feasible, assistance from the LGU is needed;

NOW, THEREFORE,

RESOLVED, as it is hereby resolved by the Members of the Sangguniang Bayan in session to endorse above mentioned Resolution to Hon. Mayor Sharon Rose G. Escoto for financial assistance for the meals of the Medical team of "Operation Tuli".
