RESOLUTION NO. 171 S-2018

A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF HEALTH-CENTER FOR HEALTH DEVELOPMENT BICOL (DOH-CHD BICOL) TO ESTABLISH AND OPERATIONALIZED SERVICE DELIVERY NETWORK (SDN) IN GUPRIBBAR INTER-LOCAL HEALTH ZONE.

WHEREAS, the Department of Health-Center for Health Development-Bicol, in support of the partnership towards Service Delivery Network (SDN) operationalization at the Inter-local Health Zone (ILHZ) level, shall transfer funds in the amount of One Hundred Thousand Pesos Only (Php 100,000.00) after a comprehensive Activity Proposal is submitted to DOH-CHD Bicol and approved by the Regional Director;

WHEREAS, Service Delivery Network (SDN) as defined by the Responsible Parenthood and Reproductive Health (RPRH) Law, refers to the network of health facilities and providers within the province-or-city-wide health system, offering core packages of health care services in an integrated and coordinated manner;

WHEREAS, this local government unit as partners of DOH-CHD BICOL in the delivery of basic health services agreed to abide with the guidelines that said amount shall be utilized to conduct capability building activities related to Service Delivery Network and support to operationalized the same;

WHEREAS, to facilitate release of the funds to this Inter-local Health Zone requires this local government unit to enter into Memorandum of Agreement with the DOH-CHD BICOL;

NOW THEREFORE, on motion of Hon. Valentin A. Pura IV and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Health-Center for Health Development Bicol (DOH-CHD BICOL) to establish and operationalized Service Delivery Network (SDN) in GUPRIBBAR Inter-Local Health Zone;
