A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE ECPAC SYSTEMS CORPORATION REGARDING AMENDMENT/ADDENDUM TO THE PREVIOUS MEMORANDUM OF AGREEMENT (MOA) DATED MAY 01, 2018 ON THE RENEWAL OF COMPUTER-BASED APPLICATION SOFTWARE PACKAGE USED BY THE OFFICES OF MUNICIPAL ACCOUNTANT AND BUDGET OFFICER

WHEREAS, the Local Government Unit of Gubat through its local chief executive will enter into Memorandum of Agreement with the ECPAC Systems Corporation regarding additional installation of FMI/BOS Software on one (1) unit computer/hardware for the use of Municipal Accountant and Budget Offices;

WHEREAS, said Memorandum of Agreement is an addendum/amendment to the Memorandum of Agreement dated May 01, 2018 previously entered by this local government unit with the ECPAC Systems Corporation on the renewal of computer-based application software package;

WHEREAS, the addendum/amendment referred to in the new Memorandum of Agreement pertains to the obligation of this local government unit to pay additional amount of Two Thousand Five Hundred Pesos (P2,500.00) representing installation fee for the additional unit of computer to be installed with the FMIS software and an additional monthly rental rate of Five Thousand Six Hundred Pesos (P5,600.00) per month which will take effect on January 1, 2019;

WHEREAS, said amount is also in addition to the Twelve Thousand One Hundred Pesos (P12,100.00) representing subscription fee per month of this local government unit on the existing FMIS/BOS Software already installed by the ECPAC Systems Corporation under Memorandum of Agreement dated May 01, 2018;

WHEREAS, the amendment/addendum to the Memorandum of Agreement dated May 01, 2019 is necessary before this local government unit can install additional software and can fully subscribed with the FMIS software of the ECPAC Systems Corporation;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the ECPAC Systems Corporation regarding amendment/addendum to previous Memorandum of Agreement dated May 01, 2018 on the renewal of Computer-Based Application Software Package used by the Offices of Municipal Accountant and Budget Officer;
