A RESLUTION AUTHORIZING HONORABLE SHARON ROSE G. ESCOTO MUNICIPAL MAYOR TO ENTER INTO A MEMORNDUM OF AGREEMENT (MOA) WITH THE FRANCE VOLUNTEERS (FV) AND THE PHILIPPINE NATIONAL VOLUNTEER SERVICE COORDINATING AGENCY (PNVSCA) FOR THE HEREDACION-HERIRAGE CONSERVATION PROGRAM.

WHEREAS. the Local Government Unit of Gubat shall provide technical and administrative support services to the volunteers including orientation and continuing guidance on project implementation;

WHEREAS, the France Volunteers (FV) shall deploy volunteers to the LGU that will provide technical support and ensure that the LGU of Gubat is consulted and made aprt of the planning and implementation of the activities;

RESOLVED, as it is hereby resolved to authorize Honorable Sharon Rose G. Escoto, Municipal Mayor to enter into a Memorandum of Agreement with the France Volunteers (FV) and the Philippine National Volunteer Service Coordinating Agency (PNVSCA) for the Heredacion - Heritage Conservation Program;
