A RESOLUTION ENDORSING TO THE HEIRS OF ESCUREL-SABATER BARANGAY COTA NA DACO RESOLUTION NO. 31, S-218, REQUESTING TO DONATE PARCEL OF THEIR LOT IN GUMANG, COTA NA DACO, TO BE USED AS HOUSING RELOCATION OF THE DISPLACED FAMILIES OF THE DPWH CONSTRUCTION OF GUBAT BY-PASS DIVERSION ROAD INCLUDING ACQUISITION OF ROAD RIGHT-OF-WAY.

WHEREAS, submitted for consideration before this Sangguniang Bayan is Barangay Cota na Daco Resolution No. 31, S-2018, requesting the Heirs of Escurel-Sabater to donate parcel of their lot located at Gumang, Cota na Daco, to be used as relocation site for the displeased families of the on-going construction of Gubat by-pass diversion road including road right-of-way acquisition;

WHEREAS, considering that the said barangay resolution concern about the immediate request of Barangay Cota na Daco to the Heirs of Escurel-Sabater for the donation of a certain parcel of land owned by them for the benefits of the estimated forty-six (46) families of the barangay that will be affected and displaced by the aforementioned project, this Sangguniang Bayan deemed it appropriate to endorse or assist the herein request of Barangay Cota na Daco as part of its commitment to promote the general welfare of the inhabitants they are representing;
