A RESOLUTION TO OPEN ACCOUNT FOR GUBAT RURAL HEALTH UNIT-HEALTH CARE INSTITUTION CHARGES AND GUBAT RURAL HEALTH UNIT-HEALTH CARE INSTITUTION PROFESSIONAL FEES WITH THE LAND BANK OF THE PHILIPPINES (LBP) SORSOGON BRANCH AND AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR AND REYMUNDO F. QUINONES, MUNICIPAL TREASURER AS SIGNATORIES THEREOF.

WHEREAS, the PhilHealth Auto Credit Payment Scheme (ACPS) Policy implementation aims to improve claim process efficiency by automating PhilHealth's payment mechanism with the Health Care Institution's banking service providers;

WHEREAS, the ACPS policy shall guide Health Care Institution (HCI) by prescribing standard requirements for HCI autocredit registration, official receipt information and autocredit payment schedules;

WHEREAS, the Gubat Rural Health Unit, Under the Local Government Unit of Gubat shall be required to open deposit accounts/s with the local banks authorized to do banking business in the Philippines under the supervision and regulation of the Banko Sentral ng Pilipinas, for the PhilHealth autocredit payment facility. The Deposit account/s shall be the destination account into which reimbursements will be credited;

RESOLVED, as it is hereby resolved, to open account for Gubat Rural Health Unit-Health Care Institution Charges and Gubat Rural Health Unit-Health Care Institution Professional Fees with the Land Bank of the Philippines (LBP) Sorsogon Branch and authorizing Hon. Sharon Rose G. Escoto, Municipal Mayor and Reymundo F. Quinones, Municipal Treasurer as signatories Thereof.
