ABAWAG, CESO IV, OIC, REGIONAL EXECUTIVE DIRECTOR, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR), REGION V, THRU ATTY. RONEL P. SOPSOP, OIC - PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICE (PENRO), SORSOGON CITY, FOR SETTLEMENT AND CONDUCT OF POLITICAL BOUNDARY SURVEY OF BARANGAYS STA. ANA AND LUNA CANDOL, ALL OF GUBAT, SORSOGON.

WHEREAS, series of committee meetings were conducted by the Committee on Rules, Ethics and Revision of Ordinances of the Sangguniang Bayan of Gubat, Sorsogon to amicably settle the issue submitted by barangay Sta. Ana (Brgy. Resolution No. 5, S-2018) regarding settlement of boundary dispute between them and Barangay Luna Candol, all of Gubat, Sorsogon;
