A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE GUBAT PUBLIC LIBRARY COMMITTEE REGARDING TRANSFER OF OWNERSHIP OF THE GUBAT PUBLIC LIBRARY.

WHEREAS, there is hereby established a two-storey building known as the Gubat Public Library which was then constructed through the joint effort of HON. DEOGRACIAS B. RAMOS, Representative, 2nd District of Sorsogon, Amiga Mano Foundation, Inc. and this local government unit under Memorandum of Agreement executed sometimes in the year 2011;

WHEREAS, this Gubat Public Library was launched primarily to provide this municipality a center for information and research, offering the educational facilities free and accessible to the public;

WHEREAS, there is also constituted a Gubat Public Library Committee who is responsible to look into the management and operation of the Gubat Public Library;

WHEREAS, to cater more extensive and efficient services to the public, the library committee deemed it appropriate to transfer the operation and management of the Gubat Public Library to the Local Government Unit of Gubat being one of the stakeholders of the information centre;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Cesar D. Esperida, Jr., Hon. Kenneth D. Escandor and Hon. Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Gubat Public Library Committee regarding transfer of ownership of the Gubat Public Library;

RESOLVED FURTHER, that copy of this resolution be furnished Hon. Sharon Rose G. Escoto, Municipal Mayor, Ms. Bernarditas B. Ramos, Chairman, Gubat Public Library Committee, and Hon. Deogracias B. Ramos, Jr. Representative, 2nd Congressional District, Province of Sorsogon; and all other offices concerned for their information and guidance.
