A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO REPRESENT THE MUNICIPALITY WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) WITH REGARDS TO ITS APPLICATION FOR FORESHORE LEASE AGREEMENT COVERING FORESHORE LANDS WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY of GUBAT, SORSOGON

WHEREAS, the Local Government Unit of Gubat finds it necessary to declare foreshore lands within its territorial jurisdiction as Ecological Tourism Zone to ensure the conservation of natural biodiversity and preservation of the area;

WHEREAS, primary to the declaration of this foreshore lands as Ecological Tourism Zone, the municipality needs to apply for a Foreshore Lease Agreement with the Department of Environment and Natural Resources (DENR) to institutionalize

cohesive partnership between the national government and this LGU for the conservation and maintenance of an ecologically balanced environment for sustainable use in the future;
