A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT WITH THE UNIVERSITY OF THE PHILIPPINES LOS BAÑOS REGARDING COLLABORATION FOR THE FORMULATION AND INTEGRATION OF THE GUBAT LGU CLIMATE AND DISASTER RISKS ASSESSMENT (CDRA) PLAN

WHEREAS, the Local Government Unit of Gubat in collaboration with the University of the Philippines Los Baños mutually agreed in the formation of scientifically grounded policy and capacity interventions in the context of climate change adaptation and mitigation of the Municipality of Gubat specifically in the formulation of its Climate and Disaster Risks Assessment (CDRA) Plan and the integration of the CDRA Plan to other local development plans of the municipality;
