RESOLUTION NO. 33 S-2018

A RESOLUTION SUSPENDING THE CONDUCT OF HEARING AND INVESTIGATION OF ADMINISTRATIVE CASE NO. 2018-01 FILED BY KGD. CRISELDA P. ENORME, COMPLAINANT, AGAINST BRGY. CAPT. RAMILO S. FAJARDO, RESPONDENT, FOR GRAVE MISCONDUCT.

WHEREAS, SEC. 61. (c) of RA 7160 otherwise known as the Local Government Code of 1991 provides that *“A verified complaint against any erring local elective official shall be prepared as follows... (c) A complaint against any elective barangay official shall be filed before the sangguniang panlungsod or sangguniang bayan concerned whose decision shall be final and executory.*

WHEREAS, an Administrative Complaint was filed by KGD. CRISELDA P. ENORME against BRGY. CAPT. RAMILO S. FAJARDO dated and received by the Sangguniang Bayan of the Municipality of Gubat on January 22 2018 for Grave Misconduct.

WHEREAS, the Verified Answer was filed by Brgy. CAPT. RAMILO S. FAJARDO dated and received by the Sangguniang Bayan of the Municipality of Gubat on February 26, 2018.

WHEREAS, SEC. 62. (c) of RA 7160 otherwise known as the Local Government Code of 1991 provides that “*However, no investigation shall be held within ninety (90) days immediately prior to any local election, and no preventive suspension shall be imposed within the said period. If preventive suspension has been imposed prior to the 90-day period immediately preceding local election, it shall be deemed automatically lifted upon the start of the aforesaid period.*”

NOW, THEREFORE, on unanimous motion it was;

RESOLVED, as it is hereby resolved to suspend the conduct of hearing and investigation of Administrative Case No. 2018-01 filed by Kgd. Criselda P. Enorme, complainant, against Brgy. Capt. Ramilo S. Fajardo, respondent, for Grave Misconduct
