RESOLUTION NO. 38 S-2018

A RESOLUTION OF COMMENDATION AND RECOGNITION TO ATTY. AUGUSTO CEASAR ERMINO, ASSISTANT MUNICIPAL TREASURER OF THE MUNICIPALITY OF GUBAT, FOR PASSING THE INTERMEDIATE COMPETENCY ON LOCAL TREASURY EXAMINATION (ICLTE) WITH THE AVERAGE SCORE OF 84.51%, RANKING 7TH PLACE AND ATTAINING THE DOF-BLGF LOCAL TREASURY CERTIFICATION.

WHEREAS, ATTY. AUGUSTO CEASAR ERMINO began his service in the Local Government Unit of Gubat on December 25, 1997. He passed his Career Executive Service Eligibility Exam (CESE) on the year 2007. The above-mentioned personnel pursued his study in the field of Law who successfully passed the Bar Examination on March 20, 2013. By the year 2015, he took the Basic Competency on Local Treasury Service (SEAL 1) and passed the same which qualified him for the Intermediate Competency on Local Treasury Service Examination (SEAL 2).

WHEREAS, Pursuant to Department Order No. 053.2016, the Seal Program is a joint undertaking by the Department of Finance and the Bureau of Local Government Finance in cooperation with the Civil Service Commission, aims to further professionalize

and benchmark the competencies of local treasury officers in the spirit of good fiscal governance and local public financial management through a competency assessment examination;

WHEREAS, the Seal 2 – Intermediate Competency on Local Treasury Service was held last November 26, 2017, Sunday in Legazpi City was the date and venue of the examination attended by Atty. Augusto Ceasar Ermino, Assistant Municipal Treasurer of the Municipality of Gubat;

WHEREAS, by virtue of Memorandum Circular No. 001-2018, the official list of successful examinees of the Intermediate Competency on Local Examination conducted by the Civil Service Commission was released and the above-mentioned personnel was one of the successful examinees of the exam conducted.

WHEREAS, the DOF-BLGF released last March 7, 2018, Wednesday, that 83 passers out of 233 examinees of the ICLTE, Augusto Ceasar Ermino was ranked 7th place attaining the 84.51% average in the aforesaid examination;

WHEREAS, for the dedication and commitment exemplified by ATTY AUGUSTO CEASAR ERMINO for the honor and public service he provides for the Municipality and all its constituents, these success and achievement will serve as an inspiration to all the constituents of the Municipality of Gubat and shall serve to be a great role model for all public servants in the Municipality of Gubat.
