RESOLUTION NO. 41 S-2018

A RESOLUTION APPROVING THE APPLICATION FOR MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOPs) IN THE MUNICIPALITY OF GUBAT, SORSOGON OF FRANCISCO J. ESPINEDA, JR., EDUARDO L. ENCINARES, NIÑO S. ENERIA, RAFAEL F. BAGASALA, BRIAN B. ESPEÑA, JUAN DE JESUS, MARLON D. ROMASANTA, EDGAR H. BAGASALA, TEODULO ERMINO, FERNAN E. ESTOLONIO, NELSON C. LAROGA, REYNALDO ESTONANTO, CHARLIE SALVAN, RESTITUTO C. ESQUIVEL, JR., ROGER E. ERLANO, CRISTIAN E. ROQUE, RICO GABUYO, EDWIN E. FLORANDA, RICARTY P. MENDOZA, JOHN CARLO F. DICHE, VICENTE O. HULAR, ROMMEL E. ERESMAS, DANILO GABION, EFREN ESTUYE, JAIME O. TERREL AND IRENE F. FAJARDO.

WHEREAS, the sangguniang bayan shall have the authority to issue, revise, renew, suspend and cancel or declare the revocation and dropping of a franchise and prescribe appropriate terms and conditions therefore” (Chapter VIII, Article I, Section 24 of the Code of General Ordinances of the Municipality of Gubat);

WHEREAS, Chapter VIII, Article I, Section 10, of the same Code states that “No tricycle-for-hire or pedicab-for-hire either for passenger or for cargo or both, shall be operated in this municipality without a MTOP or POP from the Sanggunian Bayan and a corresponding permit from the Office of the Mayor under the Municipal Revenue Code”;

WHEREAS, the Sanggunian Bayan approved SB Resolution No 52 s-2017 dated April 3, 2017 suspending the issuance of new Motorized Tricycle operators Permit (MTOP) in the Municipality of Gubat Sorsogon for a period of 5 years starting April 28, 2017;

WHEREAS, consequently, Section 22 (b) (1) Municipal Ordinance No. 2014-004, provides that:

- a) When an operator with valid MTOP/POP sold his/her unit and ceased operation:
  1. *The operator shall cause the dropping of his/her MTOP/POP upon selling his/her unit and the new owner shall have preference in applying the said MTOP/POP whether there is suspension order in granting new MTOP/POP or not, as it is already an existing MTOP/POP.*

NOW, THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and duly seconded by Hon. Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved to approve the application for Motorized Tricycle Operator’s Permit (MTOPs) in the Municipality of Gubat, Sorsogon of the above named applicants;

RESOLVED FURTHER, that copies of this resolution be furnished all concerned for information and guidance.
