A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) - ENVIRONMENTAL MANAGEMENT BUREAU RO5, REGARDING ESTABLISHMENT OF MATERIALS RECOVERY FACILITY (MRF) TO THE RECIPIENT BARANGAY AND/OR CLUSTER BARANGAYS OF THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, Section 8 of RA 9003, otherwise known as the "Ecological Solid Waste Management Act of 2000, mandates the Department of Environment and Natural Resources (DENR) to provide support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, part of the implementation of solid waste management program of the Municipality of Gubat is the establishment of Materials Recovery Facility (MRF) to every barangay or cluster barangays as mandated under Section 32 of RA 9003;

WHEREAS, this local government unit to facilitate the implementation of the program need to collaborate with the DENR for financial and technical support, thus, the need for this LGU to enter into mutual agreement with the said agency;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Danilo E. Enaje, it was;

RESOLVED, as it is hereby resolved, to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into Memorandum of Agreement (MOA) with the Department of Environment and Natural Resources (DENR) – Environmental Management Bureau RO5, regarding establishment of Materials Recovery Facility (MRF) to recipient barangay and/or cluster barangays of the Municipality of Gubat, Sorsogon;
