RESOLUTION NO. 55 S-2018

A RESOLUTION SUSPENDING THE MOTORIZED TRICYCLE OPERATOR'S PERMIT (MTOPI) IN THE MUNICIPALITY OF GUBAT OF ADOLFO ESTAREJA, JR WITH CASE NUMBER 05-09-1844 AND RYAN ESQUEJO WITH CASE NUMBER 05-09-28-28 FOR A PERIOD OF ONE (1) YEAR STARTING THIS MONTH OF APRIL 2018.

WHEREAS, the Code of General Ordinances of the Municipality requires that any operator wishing to suspend service for more than one (1) month should apply in writing, subject to approval of the sangguniang bayan;

WHEREAS, the above-named applicants applied before this office for the suspension of their MTOPI for reason that their public-utility-tricycle is under repair;

WHEREAS, the sangguniang bayan finds the request for suspension to be proper and reasonable;

NOW, THEREFORE, on motion of Honorable John Paul E. Erlano and duly seconded by Honorable Ramon E. Entico, it was;

RESOLVED, as it is hereby resolved to suspend the Motorized Tricycle Operators Permit (MTOP) in the Municipality of Gubat of Adolfo Estrareja, Jr. with case number 05-09-1844, and Ryan Esquejo with case number 05-09-2828 for a period of one (1) year starting this month of April 2018;

RESOLVED FURTHER, that this suspension of franchise has the effect of exempting the applicant from paying parking fee starting April, 2018;

RESOLVED FURTHERMORE, that copies of this resolution be furnished Mr. Eman C. Flestado, Bicycle and Tricycle Permits Clerk-Designate, Office of the Mayor, the applicant and others concerned for their information and guidance.
