RESOLUTION NO. 8 S-2018

A RESOLUTION EXTENDING THE TIME OF PAYMENT FOR LOCAL TAXES, FEES AND CHARGES OR PENALTIES, IN THE MUNICIPALITY OF GUBAT, SORSOGON, TO FEBRUARY 20, 2018.

WHEREAS, as embodied in Section 167 of the Local Government Code of 1991, "All taxes, fees and charges shall be paid within the first twenty (20) days of January or each subsequent quarter as the case maybe;"

WHEREAS, Section 167 of R.A. 7160 likewise empowers the Sangguniang Bayan to "extend the time for payment of such taxes or charges without surcharges or penalties, but only for a period not exceeding six (6) months;"

WHEREAS, there is a necessity to extend payment in consideration of the decrease in income to local business sector due to dislocations brought about by unconstructed market facilities;

NOW THEREFORE, on motion of Hon. Anthony C. Callos and duly seconded by Hon. Cesar D. Esperida, Jr., it was;

RESOLVED, as it is hereby resolved, to extend the time of payment for the local taxes, fees and charges for the year 2017 without surcharges or penalties, in the Municipality of Gubat, Sorsogon to February 20, 2018;
