A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REGIONAL FIELD OFFICE NO. V, WITH REGARDS TO THE SPECIFIC IMPLEMENTATION OF SOCIAL PENSION PROGRAM FOR INDIGENT SENIOR CITIZENS IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, the Department of Social Welfare and Development (DSWD), is mandated to provide social welfare and development programs particularly through technical assistance and resource augmentation;

WHEREAS, the Social Pension for Indigent Senior Citizens is an additional government assistance to augment the daily subsistence and other medical needs of indigent senior citizens;

WHEREAS, the Social Pension for Indigent Senior Citizens is the provision of monthly pension to qualified indigent senior citizens in the amount of Five Hundred Pesos (500.00) as government assistance stipulated under Republic Act 9994 otherwise known as "The Expanded Senior Citizens Act of 2010);

NOW, THEREFORE, on motion of Hon. Danilo E. Enaje and unanimously seconded, it was;

RESOLVED, as it is hereby resolved to authorize Hon. Sharon Rose G. Escoto, Municipal Mayor, to enter into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD), Regional Field Office No. V, with regards to the specific implementation of Social Pension Program for Indigent Senior Citizens in the Municipality of Gubat, Sorsogon;
