A RESOLUTION AUTHORIZING HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO PURCHASE MOTOR VEHICLE FOR THE EXCLUSIVE USE OF THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE (MDRRMO), LOCAL GOVERNMENT UNIT OF GUBAT, SORSOGON, FOR ITS RESCUE AND RESPONSE ACTIVITIES

WHEREAS, pursuant to the requirements of the Department of Interior and Local Government (DILG), authority of the local chief executive from the Sangguniang Bayan to purchase a motor vehicle is necessary;

WHEREAS, this local government unit will purchase a motor vehicle to be exclusively used by the Municipal Disaster Risk Reduction Management Office (MDRRMO) for its rescue and response activities with the following specifications, to wit:
