RESOLUTION NO. 97 S-2018

A RESOLUTION ENDORSING AND INTERPOSING NO OBJECTION TO CUT TREES WITHIN THE AREA AFFECTED BY ROAD WIDENING AT BARANGAY CASILI – PAYAWIN IN REFERENCE TO THE IMPLEMENTATION OF OFF-CARRIAGEWAY IMPROVEMENT – TERTIARY ROAD – JCT. ABUYOG-GUBAT-ARIMAN BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) INFRASTRUCTURE PROGRAM .

WHEREAS, the DPWH 2<sup>nd</sup> Engineering District will undertake the implementation of road widening at barangay Casili and Payawin in reference to the Off-Carriageway Improvement - Tertiary Road - Jct. Abuyog-Gubat-Ariman Road under the CY 2018 DPWH Infrastructure Program;

WHEREAS, the implementation of the said project will require cutting of trees within the area affected by the expansion of the road;

WHEREAS, one of the requirements in securing special permit at the Department of Environment and Natural Resources (DENR) to legitimately cut trees affected by the project is the resolution of the Sangguniang Bayan endorsing and interposing no objection to cut trees within the said area;

WHEREAS, Sec. 2, par. (2) of EO 23-2011 states that "The DENR is likewise prohibited from issuing/renewing tree cutting permits in all natural and residual forests nationwide, except for clearing of road right of way by the DPWH, site preparation for tree plantations, silvicultural treatment and similar activities, provided that all logs derived from the said cutting permits shall be turned over to the DENR for proper disposal. X x x x";

WHEREAS, the Sangguniang Bayan considered the request of DPWH 2<sup>nd</sup> DEO compliant with the above provision of the law;

NOW THEREFORE, on motion of Hon. Ramon E. Entico and duly seconded by Hon. Valentin A. Pura IV, it was;

RESOLVED, as it is hereby resolved, endorsing and interposing no objection to cut trees at Barangay Casili-Payawin in reference to the implementation of Off-Carriageway Improvement -Tertiary Road -Jct. Abuyog-Gubat-Ariman Road by the Department of Public Works and Highways (DPWH) Infrastructure Program;
