AN ORDINANCE CREATING THE COMMITTEE ON HOUSING AND LAND USE IN THE SANGGUNIANG BAYAN OF GUBAT, SORSOGON.

BE IT ENACTED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. **Committee on Housing and Land Use.** There is hereby created in the Sangguniang Bayan a Committee on Housing and Land Use responsible for the study and review of proposals, projects and programs, pertaining to the use of land in the municipality, housing and subdivision proposals, and all matters pertaining to appropriation of lands within its jurisdiction.

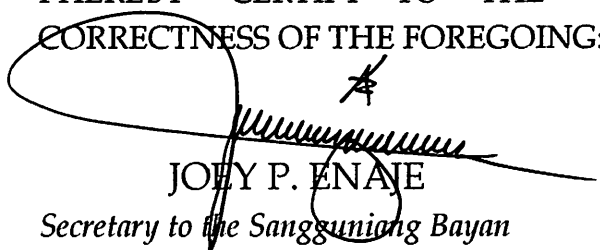
Section 2. This committee shall be in addition to the regular Sangguniang Bayan Standing Committees, the Composition of which shall be chosen by and between among the members in a manner as provided for under its Internal Rules.

Section 3. Repealing Clause. All ordinances, rules and regulations, or part thereof, in conflict with or inconsistent to the provisions of this ordinance are hereby repealed or modified accordingly.

Section 4. Effectivity. This Ordinance shall take effect upon approval.
