MUNICIPAL ORDINANCE NO. 2018 - 004

AN ORDINANCE ESTABLISHING A SCHOLARSHIP FUND FOR POOR BUT DESERVING STUDENTS RESIDING WITHIN THE MUNICIPALITY OF GUBAT.

BE IT ORDAINED BY THE SANGGUNIANG IN SESSION THAT:

Section 1. TITLE OF THE ORDINANCE. – This ordinance shall be known as "An Ordinance establishing a Scholarship Fund for poor but deserving students for Students residing within the Municipality of Gubat".

Section 2. –SCOPE OF THIS ORDINANCE. – The scholarship shall be available only to poor but deserving students at the tertiary level of the Bicol University Gubat Campus and the Sorsogon State College Campuses and exclusively the beneficiaries must be residing permanently in the Municipality of Gubat.

Section 3. – DEFINITION OF TERMS. – As used in this ordinance, the following terms shall be construed, thus:

3.1. SCHOLARSHIP – an endowment or allowance to be granted to student scholars of this Municipality;

3.2. ENDOWMENT/ALLOWANCE - the amount of money given to a particular

scholar under the program.

- 3.3. SCHOLAR is the student accepted to avail of the scholarship under this ordinance who may be qualified based on the guidelines formulated by the Scholarship Committee.
- 3.4. SCHOOL in this ordinance, shall refer only to the Bicol University Gubat Campus and Sorsogon State College Campuses.
- 3.5. POOR STUDENTS those students who belong to the low income families, the income bracket must not to exceed P6,000.00 pesos monthly. A certification from the Barangay Captain and the BIR is required to prove that the parents are earning within the P 6,000.00 bracket.
- 3.6. DESERVING STUDENTS those students from the poor families who are determined to finish their studies at tertiary level and who are qualified and who complied with all the requirements set forth under the Implementing Rules and Regulations.
- 3.7. RESIDING PERMANENTLY -those students who dwell permanently and for a long time or continuously occupy a place within the municipality as ones' legal domicile.

Section 4. – SCHOLARSHIP COMMITTEE. – There shall be created under this ordinance, a Scholarship Committee to undertake the selection and recommendation of the scholars and the corresponding endowment/allowance to the scholars based on a set of guidelines provided for in the implementing rules and regulations to be promulgated after the approval of this ordinance, with the following membership:

4.1. The Municipal Mayor - Chairman 4.2. The Vice Mayor - Vice Chairman

4.3. The Chairman and Members of the Committee on Education and Culture shall be the Members of the Committee

Section 5. SCHOLARSHIP FUND. – By the start of the school year 2018-2019, – The following shall be the basis of the yearly appropriations and its corresponding number of scholars. The appropriation shall include the existing scholarship grantees under Ordinance no. 2010-005. Each scholar shall be entitled to P 8,000.00 per semester or P16,000.00 annually. Beginning Year 2018-2019 and onwards, there shall be 60 scholarship grants to be given to First Year students and until they finished their 4 year or 5 year course. An increase in the budget shall be appropriated to cover the scholars in their 5th year course.

Year 2018-2019 - 120 scholarsP1,920,000.00Year 2019-2020 - 150 scholarsP2,400,000.00Year 2020-2021 - 180 scholarsP2,880,000.00Year 2021-2022 - 240 scholarsP3,840,000.00Year 2022 and onwardsP3,840,000.00

Section 5-1. MANDATORY FUND REQUIREMENT – To fully establish fund necessary for the implementation of this scholarship program, a mandatory appropriation should be made in the Annual Budget under the General Fund of this local government unit.

SECTION 6. – IMPLEMENTING RULES AND REGULATIONS (IRR). – A set of Implementing Rules and Regulations (IRR) shall be made providing the guidelines for the proper implementation of this ordinance which shall include among others the criteria for application, selection and approval of applicants consistent with the policy to establish scholarship program to poor but deserving students in acquiring accessible, quality, adequate education in the tertiary level. The IRR shall be formulated by the Scholarship Committee (15) days from the enactment of this ordinance, subject to ratification by the Sanggunian and final approval of the Municipal Mayor.

SECTION 7. – SEPARABILITY CLAUSE. – Should any provision of this ordinance or the application thereof be declared invalid, the remainder of the ordinance not otherwise declared so, shall remain valid and effective.

SECTION 8. – REPEALING/AMENDATORY CLAUSE. – This ordinance shall repeal Ordinance no. 2010-005 and all other ordinances, rules and regulations, executive order and portion thereof inconsistent with this ordinance are hereby repealed, amended and/or modified accordingly.

SECTION 9. - EFFECTIVITY.--This ordinance shall take effect immediately after its posting.
