MUNICIPAL ORDINANCE NO. 2018 - 007

AN ORDINANCE PRESCRIBING THE NEW FARE FOR PUBLIC-UTILITY-TRICYCLE OPERATING IN THE MUNICIPALITY OF GUBAT, SORSOGON.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. Scope. This ordinance shall prescribe the new fares for the public utility-tricycle operating within the jurisdiction of the Municipality of Gubat, Sorsogon.

Section 2. Poblacion Fare: The new fare for tricycle for hire within the poblacion shall be fixed at TEN PESOS (P10.00), comprising of the Eight (8) poblacion barangays with boundaries on the South at the Gubat South Central School and on the North at the St. Anthony Academy.

Section 3. Fares Outside Poblacion: Two Pesos (P2.00) tricycle fare increase shall be added to the present prescribed and existing tricycle fare matrix with valid issued franchise routes within the municipality.

Section 4. Discounted Fare: Students, Senior Citizens and Persons with Disabilities shall have a minimum of twenty percent (20%) discount on every route.

For students, the 20% discount shall be applicable even during Saturdays, Sundays, Holidays and other non-school days

Section 5. Exemption. The prescribed New fare shall not apply when the public utility-tricycle is chartered or on special trip where the fare is agreed upon by both the driver and the passenger.

Section 6. Penal Provisions. Any driver of public-utility-tricycle operating in the Municipality of Gubat and/or any operator who shall give consent or knowingly allow his driver to collect fare in violation of Section 2, 3, 4 and 7 shall be penalized in the following manner:

In case of insolvency of the violator, the apprehending member of the Gubat Municipal Police Station is hereby authorized to impound the public-utility-tricycle in the following schedule, to wit:

First Offense	- Five (5) Days
Second Offense	- Ten (10) Days
Third and Succeeding Offense	- Fifteen (15) Days

Section 7. Administrative Provision. The fare increase under this Ordinance can be implemented by public utility tricycle drivers and operators only upon issuance of fare matrix and payment of prescribed fees thereof at the Municipal Treasurer's Office.

Section 8. Repealing Clause. Article B, Chapter XIV of Municipal Ordinance No.2004-001, Municipal Ordinance No. 2005-003 and Municipal Ordinance No. 2011-04 are hereby repealed.

All other ordinances which are inconsistent with any provisions of this Ordinance are hereby repealed or modified accordingly.

Section 8. Effectivity. The ordinance shall take effect immediately after publication for Three (3) consecutive weeks in a newspaper of general circulation in the Province of Sorsogon.


