AN ORDINANCE FIXING TO ONE THOUSAND ( P1,000.00) PESOS, THE MONTHLY MUNICIPAL HONORARIUM OF CHILD DEVELOPMENT WORKERS (CDW's) IN THE MUNICIPALITY OF GUBAT, SORSOGON.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. This Ordinance fixes the municipal monthly honorarium of Child Development Workers (CDW's) in the Municipality of Gubat, Sorsogon from Seven Hundred Pesos (P700.00) to One Thousand Pesos (Php. 1,000.00) starting the month of January, 2019 and onwards.

Section 2. Coverage. This Ordinance shall cover all Child Development Workers (CDW's) in the Municipality of Gubat, Sorsogon recognized and registered with the Municipal Social Welfare and Development Office (MSWDO) of the local government unit of Gubat.

Section 3. Objectives. This ordinance is in recognition of CDW's effort and role in community-building and to boost their morale to continue serving the people of Gubat through giving supplemental parental care to children below (5) years old.

Section 4. Appropriation. It shall be mandatory for the local government unit of Gubat to regularly appropriate sufficient funds to be included in its Annual General Fund Budget to ensure the proper implementation of this ordinance

Section 5. Repealing Clause. All ordinances, executive orders, issuances including rules and regulations inconsistent with this Ordinance are hereby repealed, amended and/or modified accordingly.

Section 6. Effectivity. This Ordinance shall take effect upon its approval.
