MUNICIPAL ORDINANCE NO. 2019 - 006

AN ORDINANCE AMENDING SECTION 5 OF MUNICIPAL ORDINANCE NO. 2018-004, "AN ORDINANCE ESTABLISHING A SCHOLARSHIP FUND FOR POOR BUT DESERVING STUDENTS RESIDING WITHIN THE MUNICIPALITY OF GUBAT.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF GUBAT, SORSOGON IN SESSION, THAT:

Section 1. This ordinance shall amend Section 5 of Municipal Ordinance No. 2018-004, otherwise known as "An Ordinance Establishing a Scholarship Fund for Poor but Deserving Students Residing within the Municipality of Gubat", which read as follows:

Section 5. SCHOLARSHIP FUND. - By the start of the school year 2018-2019, - The following shall be the basis of the yearly appropriations and its corresponding number of scholars. The appropriation shall include the existing scholarship grantees under Ordinance No. 2010-005. Each scholar shall be entitled to P8,000.00 per semester or P16,000.00 annually. Beginning year 2018-2019 and onwards, there shall be 60 scholarship grants to be given to First Year students and until they finished their 4 year or 5 year course. An increase in the budget shall be appropriated to cover the scholars in their 5th year course.

Year 2018-2019 - 120 scholars	P 1,920,000.00
Year 2019-2020 - 150 scholars	P 2,400,000.00
Year 2020-2021 - 180 scholars	P 2,880,000.00
Year 2021-2022 - 240 scholars	P 3,840,000.00
Year 2022 and onwards	P 3,840,000.00

Section 2. For purposes of this amendment, amend Section 5 by adding additional paragraph, and will now read as follows:

Section 5. SCHOLARSHIP FUND. - By the start of the school year 2018-2019, - The following shall be the basis of the yearly appropriations and its corresponding number of scholars. The appropriation shall include the existing scholarship grantees under Ordinance No. 2010-005. Each scholar shall be entitled to P8,000.00 per semester or P16,000.00 annually. Beginning year 2018-2019 and onwards, there shall be 60 scholarship grants to be given to First Year students and until they finished their 4 year or 5 year course. An increase in the budget shall be appropriated to cover the scholars in their 5th year course.


Year 2018-2019 - 120 scholars	P 1,920,000.00
Year 2019-2020 - 120 scholars	P 1,920,000.00
Year 2020-2021 - 180 scholars	P 2,880,000.00
Year 2021-2022 - 240 scholars	P 3,840,000.00
Year 2022 and onwards	P 3,840,000.00

In the event that the number of sixty (60) scholars beneficiary for any year level under this ordinance shall decrease because of any scholarship requirements that is not complied with, and/or voluntary relinquishment of scholarship grant for reason of availment of other scholarship program, the corresponding budget for the beneficiaries shall be allocated to the new applicants in the same year level to complete the sixty (60) scholarship grants offered by this municipality.

Section 3. Effectivity. This Ordinance shall take effect upon approval.
