AN ORDINANCE AMENDING CERTAIN PROVISIONS OF MUNICIPAL ORDINANCE NO. 2015-006, "AN ORDINANCE ESTABLISHING A SENIOR CITIZEN BURIAL ASSISTANCE FUND IN THE MUNICIPALITY OF GUBAT, SORSOGON AND PROVIDING FUNDS THEREFOR.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF GUBAT IN SESSION, THAT:

Section 1. This ordinance shall amend Section 4 and Section 9 of Municipal Ordinance No. 2015-006, otherwise known as "An Ordinance Establishing a Senior Citizen Burial Assistance Fund in the Municipality of Gubat, Sorsogon and Providing Funds Therefor", which read as follows:

Section 4. Burial Assistance - an amount of ONE THOUSAND (Php1,000.00) PESOS may be claimed by the beneficiary of the deceased senior citizen upon submission and compliance of Sections 5, 6 and 7.

Section 9. Funding - The Municipal Government, in its Annual Appropriation Ordinance, shall appropriate an amount of One Hundred Thousand Pesos (Php 100,000.00). In case the appropriated amount is not sufficient, additional appropriation shall be included in any succeeding supplemental budget or realignment.

Section 2. For purposes of this amendment, amend Section 4 and 9, and will now read as follows:

Section 4. Burial Assistance - an amount of TWO THOUSAND (Php 2,000.00) PESOS may be claimed by the beneficiary of the deceased senior citizen upon submission and compliance of Sections 5, 6 and 7.

Section 9. Funding - The Municipal Government, in its Annual Appropriation Ordinance, shall appropriate an amount of Two Hundred Thousand Pesos (Php 200,000.00). In case the appropriated amount is not sufficient, additional appropriation shall be included in any succeeding supplemental budget or realignment.

Section 3. Effectivity. This Ordinance shall take effect upon approval.
