MUNICIPAL ORDINANCE NO. 2019 - 010

AN ORDINANCE GRANTING FIVE THOUSAND (P5, 000.00) PESOS MONTHLY ALLOWANCE TO THE HEAD OF THE OFFICE OF THE SENIOR CITIZEN AFFAIRS (OSCA) IN THE MUNICIPALITY OF GUBAT, PROVINCE OF SORSOGON.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. This ordinance authorizes the grant of Five Thousand (P5, 000.00) Pesos monthly allowance to the Head of Senior Citizen's Affairs (OSCA) in the Municipality of Gubat, Province of Sorsogon.

Section 2. Responsibility of the Head of OSCA. The Head of OSCA while receiving the allowance herein provided, shall be required to submit a monthly accomplishment report of the activities conducted copy furnished the Office of the Municipal Mayor and he Municipal Social Welfare and Development Office (MSWDO);

Section 3. Appropriations. The Municipality shall appropriate sufficient funds for the implementation of this ordinance, to be included in the Annual Budget for every calendar year.

Section 4. Section 3. AMENDATORY PROVISIONS. SB Resolution No. 127 s – 2010 dated November 8, 2010 and all other ordinances, resolutions, executive orders and issuances which are in conflict with the provisions of this ordinance are hereby repealed, amended and/or modified accordingly.

Section 5. This ordinance shall take effect beginning on January 1, 2020.
