MUNICIPAL ORDINANCE NO. 2019 - 011

AN ORDINANCE DECLARING THE TOTAL LAND AREA OF 3.30 HECTARES AT BARANGAY TIRIS, GUBAT, SORSOGON AS THE NURSERY SITE FOR THE ESTABLISHMENT OF THE SORSOGON PROVINCIAL CRABLET NURSERY PROJECT IN THE MUNICIPALITY OF GUBAT, SORSOGON.

BE IT ENACTED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. This ordinance shall declare a nursery site for the establishment of the Sorsogon Provincial Crablet Nursery Site in the Municipality of Gubat, Sorsogon

Section 2. Location and Technical Description. The nursery site is hereby declared covering a total land area of 3.30 hectares, (portion of Block - C, Timberland consisting of 314 Hectares), located at Barangay Tiris, Gubat, Sorsogon particularly described, as follows, to wit:

Section 4 Separability Clause

If, for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and in effect.

Effectivity Clause Section 5.

This ordinance shall take effect after its posting in at least two (2) conspicuous places in the municipality and its publication in a local newspaper of general circulation in the Province of Sorsogon.
