AN ORDINANCE TO GRANT FINANCIAL ASSISTANCE TO PERSONS WITH DISABILITIES (PWD) STUDENT AND PROVIDING FUNDS THEREFORE.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN IN SESSION THAT:

Section 1. TITLE - This ordinance shall be known as "Transportation Assistance for Persons with Disabilities (PWD) Student Ordinance".

Section 2. PURPOSE - This ordinance is enacted in order to provide transportation allowances for PWD students in all levels, enrolled in both public or private schools, colleges or universities within the Province of Sorsogon.

Section 3. DEFINITION OF TERMS – For purposes of this ordinance the following terms shall mean:

- a) **Persons with Disability (PWD)** – a Gubatnon PWD are those who have long-term physical, mental, intellectual or sensory impairments which in interaction with various barriers may hinder their full and effective participation in society on an equal basis with others. He must be pursuing his/her studies in any level and enrolled in any public or private school, college or universities within the Province of Sorsogon.

Section 4. AVAILMENT, COVERAGE AND SCHEDULE OF RELEASE – The Municipality of Gubat shall assume the actual and full transportation fare expenses of the PWD Student on a daily basis, computed from the residence to the school, college or university and vice versa. This benefit may be claimed every 1st working day of the Month at the Municipal Social Welfare and Development Office (MSWDO).

The MSWD Office shall determine the amount of transportation assistance that can be availed of by the PWD on the basis of the actual prevailing fare rates applicable.

Section 5. REQUIREMENTS – The applicant must submit the following documents to the Municipal Social Welfare Development Office (MSWDO).

1. Photocopy of PWD ID issued by the Municipal Social Welfare and Development Office.
2. Philippine Statistics Authority issued Certificate of Live Birth
3. Certified True Copy of school Registration Form
4. Certification from the Punong Barangay that the applicant is a resident of the said Barangay.
5. Certification from the School Head that the PWD is regularly attending the classes

Section 6. OBLIGATIONS OF THE BENEFICIARY.

1. Attendance in school as certified by the School Head.
2. Participation in PWD affairs especially during the observance of National Disability Prevention and Rehabilitation (NDPR) week Celebration and International day for PWD's.

Section 7. APPROPRIATION. – The Municipality shall include in its Annual Budget the amount of FIVE HUNDRED THOUSAND (P500, 000.00) for the implementation of this ordinance and shall be augmented as the need arises.


Section 8. SEPARABILITY CLAUSE. – Should any provision or portion of this ordinance be declared unconstitutional, the other parts thereof which are not affected thereby shall continue to be in full force and effect.

Section 9. REPEALING CLAUSE.– All ordinances, executive issuances, rules and regulations or parts thereof, which are inconsistent or in conflict with the provisions of this Ordinance, are hereby repealed and/or modified accordingly.


Section 10. EFFECTIVITY.- This ordinance shall take effect starting January 1, 2020.
