MUNICIPAL ORDINANCE NO. 2020 - 004

AN ORDINANCNE PRESCRIBING THE NEW IDENTIFICATION CARD FOR PERSONS WITH DISABILITY (PWD) AND SENIOR CITIZENS.

BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF GUBAT, SORSOGON THAT:

Section 1. **Title.** This ordinance shall be known as the "New Identification Card for Persons with Disability (PWD) and Senior Citizen".

Section 2. **Prescription of New Identification Card for PWD and Senior Citizens.** A new PWD and Senior Citizen's identification card (ID) is hereby prescribed effective January 1, 2021.

Section 3. The New ID Card for Senior Citizen;

3.1. The new ID shall be of polyvinyl chloride material (PVC) measuring about five by eight centimeters.

3.2.. The front shall be colored with predominant gold and white background.

3.3. The front shall be bear:

a. The heading: "Republic of the Philippines/Municipality of Gubat/Office for Senior Citizens Affairs (OSCA); the image of the Philippine Flag; the official seal of the municipality of Gubat;

b. The Senior Citizen's photograph;

c. his/her full name---given name, middle name, surname;

d. the senior citizen's address;

e. date of birth;

f. gender;

g. Date Issued and ID number;

h. The Senior Citizen's signature or thumb mark.

3.4. The back shall bear:

a. Names of person to notify in case of emergency, together with their address and contact number;

b. The Mayor's name and signature;

c. Name and signature of the OSCA Head.

3.5.. The front shall indicate the validity of the ID for use nationwide. The back shall warm on penalties for violation of RA 9994.

Section 4. The New ID Card for Persons with Disability;

4.1. The new ID shall be of polyvinyl chloride material (PVC) measuring about five by eight centimeters.

4.2. The front shall be colored with predominant white and green background.

4.3. The front shall be bear:

a. the heading: "Republic of the Philippines/Municipality of Gubat/Persons with Disabilities Affairs Office (PDAO); the official seal of the Municipality of Gubat;

b. the PWD's photograph;

c. his/her full name---given name, middle name, surname;

d. the PWD's address;

e. type of disability;

f. gender;

g. Date Issued and ID number,

h. The PWD's signature or thumb mark

4.4. The back shall bear;

- a. Names and person to notify in case of emergency, together with their address and contact number;
- b. The Mayor's name and signature;
- c. Name and signature of the PDAO Officer.

4.5. The front shall indicate the validity of the ID for use nationwide. The back shall warn on penalties for violation of RA's 10754 and 9442.

Section 5. Validity of PWD's ID Card. The issued ID card for PWD shall be valid for Three (3) years from the date of its issuance.

Section 6 Replacement of old ID Cards. PWD and Senior Citizens applying for replacement of their old IDs with the new ones shall surrender their old ID card. All old ID cards shall be replaced with the new ID card free of charge.

Section 7. Requirements for the Registration of Persons with Disability. PWD applying for registration shall submit the following:

- a. Duly accomplished application form;
- b. A duly signed clinical abstract by any licensed private or government clinic or hospital-based physician;
- c. Barangay Certificate of Residency.

Section 8. Requirements for Registration of Senior Citizens. Senior Citizen applying for registration shall submit the following:

- d. Duly accomplished application form;
- e. Birth Certificate (optional)
- f. Barangay Certificate of residency, and;
- g. Community Tax Certificate (Cedula)

Section 9. Replacement of Lost ID Cards. All PWD and Senior Citizen applying for replacement of their lost old or new IDs with the new ones shall submit an affidavit of loss. One hundred pesos (P100.00) shall be charged for the replacement.

Section 10. Appropriation. The amount of Three Hundred Thousand (300,000.00) Pesos is hereby appropriated to cover the cost for the new ID Card. Fund for the implementation of this ordinance shall be included in the 2021 Annual Budget under the Office of the Municipal Social Welfare and Development Office (MSWDO) and in every succeeding budget year thereafter.

Section 11. Separability Clause - Should any portion or provisions of this ordinance be declared unconstitutional or invalid, the other parts or provisions thereof which are not affected thereby shall continue to be in full force and effect.

Section 12. Repealing Clause - Any provision of ordinance, rules and regulations and/or parts thereof inconsistent with the provisions of this ordinance are hereby repealed and/or modified accordingly.


Section 12. Effectivity. This ordinance shall take effect starting January 1, 2021.
