AN ORDINACE AMENDING CHAPTER IV, ARTICLE B (CIVIL REGISTRY FEES), SECTION 1 AND PROVIDING ADDITIONAL PROVISION TO ARTICLE H, SECTION 2 (SB-QUASI-JUDICIAL FUNCTION) OF THE 2005 REVENUE CODE OF THE MUNICIPALITY OF GUBAT, SORSOGON.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF GUBAT IN SESSION, THAT:

Section 1. This ordinance shall amend Chapter 1V, Article B, Section 1 of the 2005 Revenue Code of the Municipality of Gubat, Sorsogon, which read as follows:
