AN ORDINANCE AMENDING SECTION 5 OF MUNICIPAL ORDINANCE NO. 2010-005,"AN ORDINANCE ESTABLISHING SCHOLARSHIP FUND FOR POOR BUT DESERVING STUDENTS IN SCHOOLS LOCATED WITHIN THE JURSIDICTION OF GUBAT, SORSOGON RESIDING WITHIN THE MUNICIPALITY.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF THE MUNICIPALITY OF GUBAT IN SESSION, THAT:

Section 1. This ordinance shall amend Section 5 of Municipal Ordinance No. 2010-005, otherwise known as "An Ordinance Establishing Scholarship Fund for Poor But Deserving Students in Schools Located within the Jurisdiction of Gubat, Sorsogon Residing within the Municipality", which read as follows:

Sec. 5. SCHOLARSHIP FUND. – The following shall be the basis of the yearly appropriations from the General Fund and its corresponding number of scholars. Such budget may be increased or augmented as necessary, subject to an appropriation ordinance.

P8,000.00 each	= P240,000.00 per semester
	480,000.00 annually

Section 2. For purposes of this amendment, amend Section 5, and will now read as follows:

Section 5. SCHOLARSHIP FUND. – By the start of the school year 2018-2019, – The following shall be the basis of the yearly appropriations and its corresponding number of scholars. Each scholar shall be entitled to P 8,000.00 per semester or P16,000.00 annually.

Beginning Year 2018-2019 and onwards, there shall be 60 scholarship grants to be given to First Year students and until they finished their 4 year course.

Year 2018-2019 - 120 scholars	P1,920,000.00
Year 2019-2020 - 150 scholars	P2,400,000.00
Year 2020-2021 - 180 scholars	P2,880,000.00
Year 2021-2022 - 240 scholars	P3,840,000.00
2022 and onwards	P3,840,000.00

Section 5-1. MANDATORY FUND REQUIREMENT – to fully establish fund necessary for the implementation of this scholarship program, a mandatory appropriation should be made in the Annual Budget under the General Fund of this local government unit.

Section 3. This ordinance shall take effect January 1, 2018.
