WHEREAS, the applicants have substantially complied with the requirements for the dropping of his franchise to operate public-utility-tricycle in the municipality of Gubat;


NOW, THEREFORE, on motion of Hon. Cesar D. Esperida, Jr. and duly seconded by Hon. Danilo E. Enaje, it was;

RESOLVED, as it is hereby resolved to declare the dropping of Motorized Tricycle Operator's Permit (MTO) in the municipality of the above named applicant;


