

RESOLUTION NO. 100 S-2020

A RESOLUTION AUTHORIZING HONORABLE SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF THE PRESIDENT (OP) REGARDING THE GRANT OF FINANCIAL ASSISTANCE TO LGU'S AFFECTED BY TYPHOON "TISOY".

WHEREAS, the Office of the President (OP) will release to the Local Government Unit of Gubat the amount of Three Million Pesos (P3,000,000.00) financial assistance as grant to LGU's affected by the typhoon "Tisoy".

WHEREAS, said financial grant shall be used to cater and address the immediate needs of the people affected by the typhoon as well as to implement long term solution and provide future evacuation of people living in the hazard areas in this municipality;



WHEREAS, the local chief executive has signified to utilize the grant for the procurement of real property for the establishment of resettlement/relocation sites/areas within the municipality;

WHEREAS, the execution of Memorandum of Agreement (MOA) is one of the requirements for the release of the said financial assistance, thence, this request;


NOW THEREFORE, on motion of Honorable Danilo E. Enaje and unanimously seconded, it was;
