RESOLUTION NO. 106 S-2019

A RESOLUTION DECLARING AS VALID AND ENFORCEABLE, BARANGAY BALUD DEL NORTE ORDINANCE NO. 2019-001 AND BARANGAY COGON ORDINANCE NOS. 2019-01 AND 2019-02.

WHEREAS, That Barangay Cogon enacted the following barangay ordinances:

- a. *Barangay Cogon Ordinance No. 2019-001, "Ordinansa na Nagmamamandato sa mga Tindahan nan Establisemento sa Barangay na Magbutang sin Sadiri na Basurahan sa Tungod o Atubangan san Kanira Tindahan; and*
- b. *Barangay Cogon Ordinance No. 2019-02, "Ordinansa na Nagbabawal sa mga Tindahan sin Pagpabakalsin Sigarilyo Asin Inumon na Arak sa mga Menor de Edad na ang Edad 17 Anyos Pababa;*

WHEREAS, Barangay Balud del Norte likewise enacted Brgy. Ordinance No. 2019-01, entitled, *"An Ordinance Prohibiting the Dumping or Disposal of Garbage, or Any Waste Material, and Defecate Along the Shoreline, Beach, and During Ebb Tide Within the Territorial Jurisdiction of Barangay Balud del Norte, Gubat, Sorsogon;*

WHEREAS, Article 3, Section 391 (a) of the Local Government Code of 1991 states that, "The Sangguniang Barangay, as the legislative body of the barangay shall (1) enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants thereon";

WHEREAS, Section 447, par. (a), subpar. (1) the Sangguniang Bayan has the power and duties to "approved ordinances and pass resolutions necessary for an efficient and effective municipal government, and in this connection (i) Review all ordinances approved by the sangguniang barangay and executive orders issued by the punong barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and the punong barangay;

WHEREAS, it has been found that in the enactment of the above-mentioned ordinances, proper procedure were observed and that the same are in consonance with the Local Government Code of 1991 and other pertinent laws and local ordinances;


NOW, THEREFORE, on motion of Honorable Ramilo S. Fajardo and duly seconded by Honorable Ramon E. Entico, it was;


