

### RESOLUTION NO. 107 S-2019

A RESOLUTION AUTHORIZING THE HON. SHARON ROSE G. ESCOTO, MUNICIPAL MAYOR, TO ENTER INTO MEMORANDUM OF UNDERSTANDING (MOU) WITH THE PROVINCIAL GOVERNMENT OF SORSOGON AND WITH THE PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (PhilFIBA) FOR THE PROJECT IMPLEMENTATION OF "ABACA-ONE-PLUS-ONE SA SORSOGON" PROJECT.

WHEREAS, the Local Government Unit of Gubat, Sorsogon through the Municipal Agriculture Office will enter into Memorandum of Understanding (MOU) covering the implementation of "Abaca-One-Plus-One sa Sorsogon" Project that will be co-implemented by the Provincial Government of Sorsogon, Philippine Fiber Industry Development Authority (PhilFIDA);



WHEREAS, the project under this MOU aims to treat infected abaca farms and re-planting of same disease-treated farms in the Municipality of Gubat;

WHEREAS, the cost of the implementation of this project is One Million Pesos from the Provincial Government of Sorsogon to cover purchase of required materials and labor services;

WHEREAS, under this undertaking, the PhilFIDA shall introduce the technology on the proper cultural management on abaca production and will provide chemicals for disease treatment; and shall lead in the technical supervision, management and monitoring of the project;

WHEREAS, this project is significant to poverty alleviation program of this municipality;


NOW THEREFORE, on motion of Honorable Ramon E. Entico and duly seconded by Honorable Cesar D. Esperida, Jr., it was;
