WHEREAS; the Municipality of Gubat is composed of 42 Barangays with estimated population of 59, 534 people according to the 2015 census;

WHEREAS; all 42 Barangays have an existing and operational Barangay Health Centers with approximate staff ratio of 1 midwife is to 3 Barangays and 5-8 Barangay Health Workers per Barangay;

WHEREAS; the Barangay Health Centers aims to provide first aid, maternal and child health care, diagnosis of social diseases and other basic health services to all the member of the community it is serving;

WHEREAS; the need for medical supply and equipment are vital for the Barangay Health Practitioners to effectively and efficiently carry out their duties and responsibilities;

WHEREAS; it is a constant request of our Barangay Health Practitioners the need for additional Blood Pressure Apparatus and other medical equipment for the routine Home visit conducted by them for their constituents who are physically incapacitated to visit the Barangay Health Center;

WHEREAS; the request for Aneroid Sphygmomanometer Blood Pressure Apparatus is intended 2 for each Barangay Health Center


NOW THEREFORE, on motion of Honorable Valentin A. Pura IV, and unanimously seconded by all members present, it was;


