V, REGARDING IMPLEMENTATION OF SUPPLEMENTARY FEEDING PROGRAM TO EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) PROGRAM IN THE MUNICIPALITY OF GUBAT, SORSOGON.

WHEREAS, Supplementary Feeding Program is the provision of food in addition to the regular meals, to target children as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government;
