RESOLUTION NO. 117 S - 2019

A RESOLUTION COMMENDING THE VALUABLE EFFORT AND CONTRIBUTION OF MR. MELVIN C. GREGORIO, MR. LOUBERT E. ERGINA AND MR. JOHN MARK D. NABONG, ALL FISHERMEN AND RESIDENTS OF BRGY. BAGACAY, GUBAT, SORSOGON FOR RECOVERING FORTY PACKS OF IDENTIFIED COCAINE SUBSTANCE AT THE MUNICIPAL SEAWATERS OF GUBAT, SORSOGON ALONG BARANGAY BAGAY, GUBAT, SORSOGON.

WHEREAS, on or about 2:00 PM of May 27, 2019, Brgy. Capt. Rommel Lacandula of Brgy. Bagacay, Gubat, Sorsogon reported to Gubat Municipal Police Station regarding the recovery of unidentified substance by the above-mentioned fishermen while they were fishing at the territorial seawaters of Brgy. Bagacay, Gubat, Sorsogon;

WHEREAS, immediately after the report of Brgy. Capt. Rommel Lacandula, the Gubat Municipal Police Station led by PEMS Arman Estera, Deputy COP together with Intel Personnel proceeded to the said place to determine the veracity of the report, upon

reaching thereat the nine (9) pieces of small boxes and three (3) pieces of small boxes of unidentified chemical substance were already at the seashore loaded at motorized banca;

WHEREAS, after documentation and inventory of the above recovered boxes it was taken into custody by the Gubat PNP for proper disposition and subsequent turn over to Sorsogon Crime Laboratory for further analysis;

WHEREAS, after qualitative Examination on the thirty-eight (38) sealed rectangular packs and two (2) unsealed rectangular packs all containing pressed white powder marked as "A" through "Z" , "AA" through "AN" submitted to Sorsogon Provincial Crime Laboratory Office was yielded positive to the test for the presence of "Cocaine", as examined by P/LTCOL Josephine M. Clemen, RCH - Provincial Forensic Chemist (MMPSI Memorandum dated May 30, 2019, Subject: Progress Report on the Recovered Cocaine and Marine Instrument (M3i) or GP Buoy in the Territorial Seawaters of Bagacay, Gubat, Sorsogon);

WHEREAS, the Local Government Unit of Gubat expresses its sincerest appreciation and commendation for the valuable effort and contribution of these three (3) named fishermen, in their honest and undeniable courage to turn-over this unidentified packs and marine instrument to the proper authorities that lead to the confiscation of illegal drugs;


