

RESOLUTION NO. 118 S - 2019

A RESOLUTION COMMENDING THE VALUABLE EFFORT AND ACTIVE RESPONSE OF THE PHILIPPINE NATIONAL POLICE - GUBAT MUNICIPAL POLICE STATION (PNP - GMPS) PERSONNEL THAT LEAD TO THE RECOVERY OF THIRTY NINE (39) KILOS OF IDENTIFIED COCAINE SUBSTANCE AT THE MUNICIPAL SEAWATERS ALONG BARANGAY BAGACAY, GUBAT, SORSOGON.

WHEREAS, on or about 2:00 PM of May 27, 2019, Brgy. Capt. Rommel Lacandula of Barangay Bagacay, Gubat, Sorsogon reported to the Gubat Municipal Police Station regarding the recovery of unidentified substance by local fisherfolks while fishing at the municipal seawaters of the Municipality of Gubat along Barangay Bagacay, Gubat, Sorsogon;



WHEREAS, immediately after the report of Brgy. Capt. Rommel Lacandula, the Gubat Municipal Police Station led by PEMS Arman Estera , Deputy COP together with Intel personnel proceeded to the said place to determine the veracity of the report, upon reaching thereat the nine (9) pieces of small boxes and three (3) pieces of small boxes of unidentified chemical substance were already at the seashore loaded at motorized banca;

WHEREAS, after documentation and inventory of the above recovered boxes it was taken into custody by the Gubat PNP for proper disposition and subsequent turn over to Sorsogon Crime Laboratory for further analysis;

WHEREAS, after qualitative Examination on the thirty-eight (38) sealed rectangular packs and two (2) unsealed rectangular packs all containing pressed white powder marked as "A" through "Z" , "AA" through "AN" submitted to Sorsogon Provincial Crime Laboratory Office was yielded positive to the test for the presence of "Cocaine" more or less Thirty Nine (39) Kilos with an estimated DDB Value of Two Hundred Million (200,000,000.00) Pesos, as examined by P/LTCOL Josephine M. Clemen, RCH - Provincial Forensic Chemist;

WHEREAS, the Local Government Unit of Gubat expresses its sincerest appreciation and commendation for the valuable effort and contribution of these PNP - GMPS Personnel that lead to the confiscation of illegal drugs;

NOW THEREFORE, on motion of Honorable Valentin A. Pura IV and Honorable Cesar D. Esperida, Jr., and unanimously seconded, it was;

RESOLVED, as it is hereby resolved, commending the valuable effort and active response of the Philippine National Police - Gubat Municipal Police Station (PNP - GMPS) personnel that lead to the recovery of Thirty Nine (39) Kilos of identified cocaine substance at the territorial seawaters of the Municipality of Gubat fronting Barangay Bagacay, Gubat, Sorsogon;




