V, WITH REGARDS TO THE IMPLEMENTATION OF SOCIAL PROTECTION PROGRAMS IN THE MUNICIPALITY OF GUBAT, SORSOGON

WHEREAS, the Municipality through Memorandum of Agreement and in partnership with the Department of Social Welfare and Development (DSWD) agrees to continuously engage in developing and implementation of social protection programs that will address the needs of the poor, empower citizens, and promote inclusive growth in the municipality;


NOW THEREFORE, on motion of Hon. Danilo E. Enaje and unanimously seconded, it was;
